1 By Order issued April 2, 2010, (Docket Entry No. 44), plaintiff, the U.S. Commodity Futures  
2 Trading Commission (“Commission”), was granted until June 30, 2010, to effect service upon  
3  
4 defendant Jin K. Chung.

5 Before the Court is Plaintiff’s Motion for Extension of Time to Serve Defendant Jin K.  
6  
7 Chung. Plaintiff represents that it continues to make attempts to serve defendant Chung through  
8 the Korean authorities. Additionally plaintiff represents that the extradition process is ongoing  
9 and seeks additional time to effect service during or after the extradition of the defendant to the  
10  
11 United States.

12 Upon consideration of the plaintiff’s Motion the Court hereby GRANTS the plaintiff’s  
13  
14 request for additional time to serve the defendant. The plaintiff shall have until September 30,  
15  
16 2010 to serve defendant Chung.
