However, the Court has not yet reviewed or considered the pending motion to dismiss. Therefore, transferring this matter to the Eastern District of California will not waist judicial resources. Moreover, because the property at issue is located in the Eastern District of California and no party resides in the Northern District of California, the Court finds that transferring this matter to the Eastern District would be in the interests of justice. Therefore, the Court HEREBY TRANSFERS this matter to the Eastern District of
