19 record, file this Stipulation and Order of Dismissal under Federal Rule of Civil Procedure 41.

20 Plaintiff filed this lawsuit on June 30, 2009.

21 Plaintiff and defendant have entered into a "Release And Settlement Agreement"
22 which settles all aspects of the lawsuit against defendant. The "Release And Settlement
23 Agreement states in part that "The court shall retain jurisdiction to enforce this
24 Settlement Agreement, and this Settlement Agreement shall either be an exhibit to the dismissal
25 of the action or incorporated by reference in the dismissal as if set forth in full. The "Release
26 And Settlement Agreement" is incorporated by reference herein as if set forth in full. Plaintiff
27 and defendant stipulate to the court retaining jurisdiction to enforce the "Release And
28 Settlement Agreement."

Plaintiff moves to dismiss with prejudice the lawsuit against defendant.

Defendant, who has answered the complaint, agrees to the dismissal with prejudice.

This case is not a class action, and no receiver has been appointed.
