27	3. The parti	es shall simultaneously re-file the briefs regarding Plaintiff's survey by	
28	no earlie	than June 6, 2014. The Court shall hear that motion on Friday, July	
	11, 2014	at 9:00 a.m.	

1	4.	The deadline to submit to an ADR process shall be December 19, 2014, and the
2		parties shall submit a stipulation and proposed order selecting an ADR process
3		with that deadline by May 27, 2014.
4	5.	Close of fact discovery shall be April 30, 2015.
5	6.	Deadline to disclose expert reports shall be June 8, 2015.
6	7.	Deadline to disclose expert rebuttal reports shall be July 17, 2015.
7	8.	Close of expert discovery shall be August 21, 2015.
8	9.	The hearing on dispositive motions shall be November 6, 2015 at 9:00 a.m. If
9		the parties file cross-motions on the same issues, the Court prefers a four-brief
10		format, whereby Plaintiff files the opening motion for summary judgment,
11		Defendant files its opposition and cross-motion, Plaintiff files his opposition and
12		reply, and Defendant files its reply. There must be two weeks between the final
13		reply brief and the hearing date.
14	10.	The pretrial conference shall be held on Monday, January 25, 2016 at 2:00 p.m.
15	11.	Jury selection shall be held on Wednesday, February 10, 2016 at 8:00 a.m.
16	12.	Trial shall be held on Tuesday, February 16, 2016 at 8:00 a.m.
