**JOINT STIPULATION TO CONTINUE

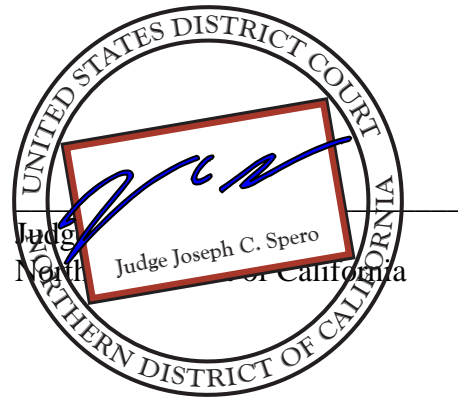
