20 1. WHEREAS on January 12, 2010, the parties participated in a full day mediation
21 session before Hon. Fern Smith (Ret.) at the JAMS offices in San Francisco, California, at which
22 time the basic terms of a settlement were discussed;

23 2. WHEREAS the parties returned to JAMS for a productive second day of mediation
