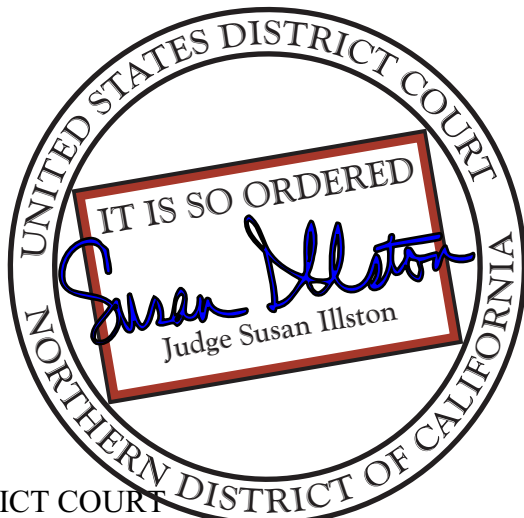

1 Pursuant to Local Rule 11-5, Pixion, Inc., through its authorized representative,
2 hereby requests that the Court terminate and/or otherwise disassociate certain counsel
3 having previously made an appearance on behalf of Plaintiff, Pixion, Inc. The grounds
4 for this request are:

5 1. Primary counsel for Pixion, Inc. is now Colby B. Springer, formerly of Carr
6 & Ferrell LLP. Since the filing of this action, Colby B. Springer has become affiliated
7 with Lewis and Roca LLP. Lewis and Roca LLP now principally represents Pixion, Inc.
8 in this matter.

9 2. Lewis and Roca LLP maintains an office in this judicial District with
10 attorneys who are admitted to practice before this Court.

11 3. The attorneys of Carr & Ferrell LLP that previously appeared on behalf of
12 Pixion are no longer authorized to represent Pixion, their representation having been
13 terminated.

14 4. Although attorneys of Carr & Ferrell LLP were previously removed from
15 this Court's docket, Christine Watson of Carr & Ferrell was not removed.

16 **WHEREFORE**, Plaintiff Pixion, Inc. respectfully requests that the Court enter an
17 Order terminating Carr & Ferrell LLP, specifically including Christine Watson, as
18 counsel of record for Plaintiff, and removing them from the docket sheet as counsel of
19 record, together with such additional relief as the Court deems just and proper.
