

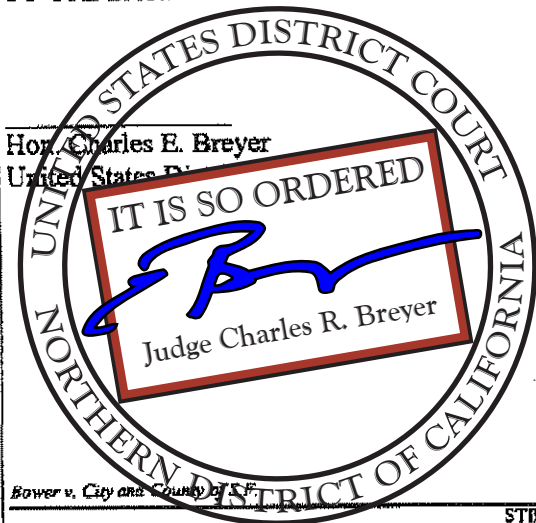
ORDER BASED ON STIPULATION
