Plaintiff Louisiana Pacific Corporation (“Plaintiff”) and defendant Money Market 1  
Institutional Investment Dealer (“MM1”), acting through their respective counsel, enter into the  
below stipulation:

WHEREAS, Plaintiff filed a First Amended Complaint (“FAC”) on March 8, 2010;

WHEREAS, on April 21, 2010, defendant Deutsche Bank Securities, Inc. filed a Motion  
to Dismiss the FAC in this Court;

WHEREAS, on April 23, 2010, MM1 filed a Motion to Dismiss the FAC in this Court;

WHEREAS, by Order dated March 28, 2011, the Court denied MM1’s Motion to  
Dismiss, granted DBSI’s Motion to Dismiss, and granted leave for Plaintiff to file a Second  
Amended Complaint (“SAC”) by April 29, 2011;

WHEREAS, the Court subsequently entered an order extending Plaintiff’s time to file its  
SAC in this Court through and until May 20, 2011; and

WHEREAS, Plaintiff has advised MM1 of Plaintiff’s intent to assert in the SAC the same  
claims against MM1 that the Court has already sustained, to be filed in this Court by May 20,  
2011, and defendant MM1 has requested and Plaintiff has agreed that MM1 shall file an Answer  
to the SAC twenty-one (21) days after Plaintiff files the SAC in this Court.

IT IS THEREFORE STIPULATED AND AGREED, by and between Plaintiff and MM1,  
acting through their respective counsel, subject to this Court’s approval, that MM1 shall file an  
Answer to the anticipated SAC twenty-one (21) days after the filing of the SAC in this Court.
