25 THEREFORE, THE PARTIES HEREBY STIPULATE AND AGREE AS FOLLOWS:


26 1. Dismissal with Prejudice. Plaintiff Catherine Pickard dismisses with prejudice her

6 IT IS SO STIPULATED.




