7 under seal:

- 9 a. The second sentence of Paragraph 9 of the Complaint (Docket No. 1), and Exhibit
10 "B" thereto;
11 b. Paragraph 12 of the Amended Complaint (Docket No. 6), and Exhibit "B," thereto;
12 c. The first and second sentence of Paragraph 12 of the Second Amended Complaint
13 (Docket No. 15), and Exhibit "B" thereto, and
14 d. The first and second sentences of Paragraph 12 of the Third of the Amended
15 Complaint (Docket No. 20), and Exhibit "B" thereto.

17 Relator's Counsel will provide the Clerk's Office with appropriately redacted Complaints in
18 accordance with this Order. The Complaints as originally filed will remain under seal.
