**STIPULATED ORDER RE: EXPERT  
 DEPOSITION SCHEDULE**

21 The parties by and through their attorneys of record hereby stipulate as follows:


- 22 (1) Pursuant to FRCP 26, the parties disclosed expert witnesses on August 3,  
 23 2010;
- 24 (2) Defendants requested that one of plaintiff's expert, Mary McGrath, be  
 25 produced for deposition, and sought dates to occur within the second week  
 26 of August;
- 27 (3) It was thereafter agreed that the deposition could proceed on September  
 28 13, 2010, and a stipulated order was executed and filed;

- 1 (4) Plaintiff was unable to produce Ms. McGrath for deposition on September  
2 13<sup>th</sup>, and the deposition was re-scheduled on October 29, 2010, and an  
3 amended stipulated order was filed;
- 4 (5) On September 23, 2010 defendants disclosed a rebuttal expert on the  
5 subject matter of Ms. McGrath's stated expertise and opinions;
- 6 (6) On September 28, 2010, the court vacated the October 1, 2010 hearing  
7 date on defendants' motion for summary judgment, finding the motion  
8 appropriate for decision without oral argument;
- 9 (7) The parties have agreed that the depositions of plaintiff's experts may be  
10 completed after receiving the court's ruling and order on defendants' motion  
11 for summary judgment;
- 12 (8) The stipulation does not alter the court's scheduling order.


