(DOC 206) IDENTITY OF PLAINTIFF
AND TO RE-TAX COSTS**

25 Plaintiff's opposition to Defendants' request for abstract of judgment to be issued
26 in name of minor plaintiff and cross-motions to seal Defendants' motion (Doc 206)
27 identify of plaintiff and to re-tax costs was filed on September 25, 2012 and Defendants
28 Willits Charter School and Sally Rulison's opposition was filed on October 4, 2012.

After full consideration of the moving papers, the opposition thereto, and the
authorities cited by the parties, the Court hereby denies plaintiff's motion in its entirety.

1 Specifically, the Court finds that Defendants' abstract of judgment has been
2 issued and properly recorded; plaintiff's correct name is required to enforce the
3 judgment pursuant to C.C.P. § 674(a)(4); the request to seal Defendants' motion is no
4 longer warranted; and plaintiff's motion to re-tax costs is untimely, as plaintiff failed to
5 file a timely objection to Defendants' bill of costs as dictated by Civ. L.R. 54-2.
