 20 **STIPULATE TO THE FOLLOWING:**

21 1. On or about October 15, 2010, all parties, through their respective counsel of
 22 record, appeared before Judge Jeffrey White at a Case Management Conference at which the
 23 parties were ordered to participate in a Settlement Conference with a randomly assigned
 24 Magistrate Judge by January 13, 2011.

25 2. On or about October 25, 2010, Magistrate Judge Bernard Zimmerman notified the
 26 parties that a Settlement Conference had been scheduled for December 14, 2010, at 2:00 p.m. in
 27 Courtroom G of the above-referenced Court.

28 3. As a result of the November 2, 2010 election, the Pittsburg Unified School

1 District's ("District") five-member Governing Board will have two new Board members taking
2 office and two current Board members leaving office on December 14, 2010. As such, the parties
3 agree that it would be premature to hold the Settlement Conference on December 14, 2010, since
4 the make-up of the District's Governing Board, who must approve any tentative agreement
5 reached at the Settlement Conference, will change on that very same day and will not have been
6 fully briefed on this litigation by District counsel.

7 5. As counsel for Defendants has confirmed with Judge Zimmerman's clerk that Judge
8 Zimmerman is unavailable during the entire month of January 2011 to conduct a Settlement
9 Conference, the parties hereby stipulate to continue the Settlement Conference to February 2011;
10 the specific date upon which shall be selected by Judge Zimmerman.

11 6. The parties further stipulate to continue additional case deadlines and dates as
12 follows:

- 13 a. ~~Further Case Management Conference – March 4, 2011~~
- 14 b. ~~Joint Supplemental Case Management Statement due – February 25, 2011~~
- 15 c. Dispositive Motion Filing Deadline – March 18, 2011
- 16 d. Hearing on Dispositive Motions – April 22, 2011 at 9:00 a.m.

17 7. ~~The parties agree that all other scheduled dates shall remain the same.~~
