1 **IT IS HEREBY STIPULATED AND AGREED** by Plaintiff, YVONNE HODGE ("Plaintiff") and
2 Defendants, OAKLAND UNIFIED SCHOOL DISTRICT, KIMBERLY NOBLE, LISA RYAN COLE,
3 AND IRIS WESSELMANN ("Defendants") (collectively, "the Parties"), that:

4 WHEREAS, the Court entered the Case Management and Scheduling Order on October 29,
5 2010 (DKT No. 44); and

6 WHEREAS, the settlement conference in this matter, having been continued twice already,
7 is scheduled for October 12, 2011,

8 The Parties hereby stipulate, agree and respectfully request that the Court continue certain

11 **EXPERT WITNESSES.** The disclosure and discovery of expert witnesses shall proceed as

17 The date for completion of all discovery of expert witnesses pursuant to Federal Rule of Civil
18 Procedure 26(b)(4) is continued from November 14, 2011 to November 23, 2011.

19 **PRETRIAL MOTIONS.** All pretrial motions must be filed and served pursuant to Civil Local
20 Rule 7. The date for all pretrial motions to be heard is continued from December 8, 2011 to
21 January 12, 2012.
