1 Pursuant to Civil Local Rules 6-1 and 6-2, Plaintiff Jose Zaldivar and the Class Members
2 (“Plaintiffs”) and Defendant Lumber Liquidators, Inc. (“Defendant”) (collectively, the “Parties”),
3 by and through their respective counsel of record, hereby stipulate to continue the following
4 deadlines:

5 May 9, 2013: Deadline to complete private mediation of plaintiff/non-class member
6 claims;

7 May 9, 2013: Deadline to complete court-sponsored mediation of class member claims;

8 and

9 June 7, 2013: Court Status Conference.

10 The Parties represent and agree as follows:

11 WHEREAS, in an Order dated February 8, 2013 (Docket No. 111), the Court referred the
12 claims of the individual plaintiffs (Crelencio Chavez, Jose Zaldivar; Carlos Alva, Andrew Owens,
13 Joel Villasenor, Rene Rodriguez and Jason Mcmillan) to private mediation and the claims of
14 Plaintiff Zaldivar and the class members to court-sponsored mediation.

15 WHEREAS, pursuant to ADR Local Rule 3-6, unless otherwise ordered, the private
16 mediation and court-sponsored mediation must be held by May 9, 2013 (within 90 days after the
17 entry of an order referring the case to a specific ADR process).

18 WHEREAS, the Court has scheduled a status conference on June 7, 2013.

19 WHEREAS, the Parties have been working cooperatively and diligently to schedule the
20 court-sponsored mediation of class member claims on a date mutually available to all Parties and
21 the Court-appointed Mediator, Richard S. Whitmore and to select a mutually agreeable private
22 mediator for the mediation of the individual plaintiff/non-class member claims.

23 WHEREAS, Defendant’s General Counsel who will attend both mediations on behalf of
24 Defendant is traveling from the East Coast and no dates prior to May 9, 2013 are mutually
25 available for the Plaintiffs’ counsel, the mediator and Defendant’s General Counsel.

26 WHEREAS, the Parties have agreed to court-sponsored mediation of the class claims on
27 Tuesday, May 21, 2013, which has been confirmed by the Court’s ADR office pending approval
28 by the Court.

1 WHEREAS, the Parties anticipate completing private mediation of the non-class member
2 claims by June 28, 2013.

3 WHEREAS, continuing the mediation deadline and the Status Conference will not affect
4 the schedule for the case because, other than the June 7, 2013 Status Conference, there are no
5 other events or deadlines on calendar for either of the related cases.

6 THEREFORE, IT IS HEREBY STIPULATED by and between Plaintiffs and Defendant
7 that the Court continue the existing mediation deadlines and Status Conference and order the
8 following:

9 May 21, 2013: Deadline to complete court-sponsored mediation of class member claims

10 June 28, 2013: Deadline to complete private mediation of individual plaintiff/non-class
11 member claims

12 July 26, 2013: Court Status Conference
