8 IT IS HEREBY STIPULATED AND AGREED among the undersigned parties as  
9 follows:

14 interrogatories pursuant to Fed. R. Civ. P. 33. This stipulation is without prejudice to further  
15 increases, if necessary, upon agreement of the parties or with leave of Court, and the parties  
16 reserve the right to oppose any such future request.
