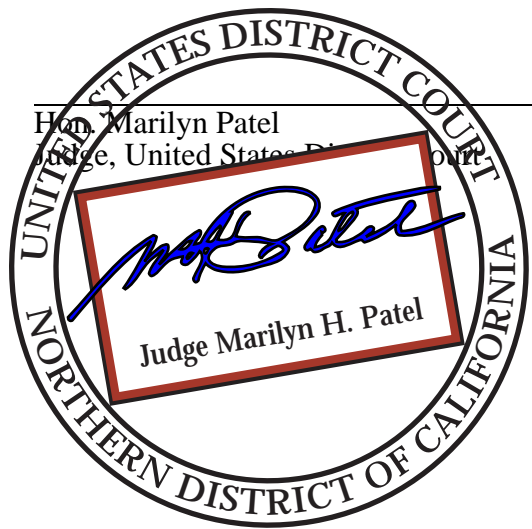
26 On November 15, 2011, this Court entered a Judgment in Favor of APL Co. PTE. Ltd.
