8 Motion by West Bay to be filed on November 15, 2010

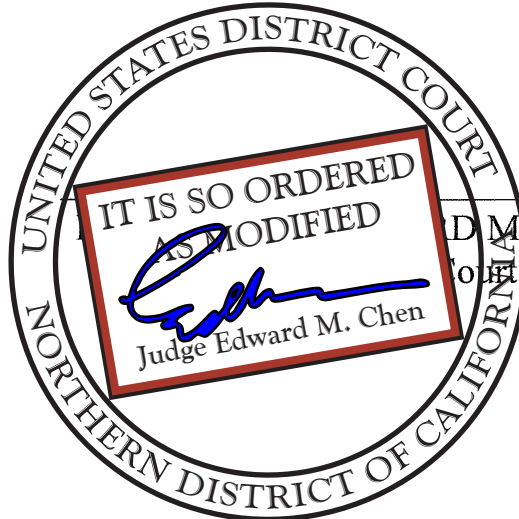
