The Court reminds Plaintiff that she has until October 13, 2010, to retain counsel and have counsel make an appearance. If no lawyer makes an appearance in this case on Plaintiff's behalf by that date, then the Court may dismiss the case in its entirety. The Court has previously referred the Plaintiff to the Legal Help Center and the Court's manual for litigants without a lawyer, which is available on the Court's website, www.cand.uscourts.gov.
