23 PURSUANT TO STIPULATION, IT IS SO ORDERED that the May 20, 2010 initial Case
 24 Management Order, as previously modified by Orders dated July 19, July 30, October 29,
 25 November 17, and December 29, 2010 is further modified as follows.

27 3. CROSS-MOTIONS FOR SUMMARY JUDGMENT. Cross-motions for summary
 28 judgment, if any, shall be heard in accordance with Civil Local Rule 7 on April 21, 2011. In that

1 regard, all cross-motions for summary judgment shall be filed no later than March 17, 2011; all
2 responses to cross-motions for summary judgment shall be filed no later than April 5, 2011; and
3 all replies in support of cross-motions for summary judgment shall be filed no later than April 12,
4 2011.

5 4. FURTHER CASE MANAGEMENT CONFERENCE. A further Case Management
6 Conference shall be held on May 19, 2011 at 10:00 a.m. in Courtroom 3, 17th Floor, United States
7 Courthouse, 450 Golden Gate Avenue, San Francisco, California. The parties shall submit a Joint
8 Case Management Statement at least one week prior to the Conference.


9 5. PRETRIAL STATEMENTS. At a time convenient to all, counsel shall meet and
10 confer to discuss preparation of a joint pretrial statement, and on or before July 28, 2011, counsel
11 shall file a Joint Pretrial Statement.

12 6. PRETRIAL CONFERENCE. The final pretrial conference will be held on August
13 11, 2011, at 10:00 a.m., in Courtroom 3, 17th Floor, United States Courthouse, 450 Golden Gate
14 Avenue, San Francisco, California. Each party or lead counsel who will try the case shall attend
15 personally.

16 7. TRIAL DATE. Jury trial shall commence on August 29, 2011, at 9:00 a.m. in
17 Courtroom 3, 17th Floor, United States Courthouse, 450 Golden Gate Avenue, San Francisco,
18 California.
