
~~PROPOSED~~ ORDER

1 After consideration of Intervenor Bipartisan Legal Advisory Group's ("BLAG's")  
2 Motion for Leave to File Superseding Opposition to Plaintiff's Motion for Summary Judgment  
3 (Dkt. 168), the papers filed by plaintiff Karen Golinski in response thereto, and all other matters  
4 presented to the Court, and good cause so appearing, the Court hereby ORDERS as follows:
