1 1. This is an ERISA long term disability case in which the Court has set cross-
2 motions for summary judgment to be heard on April 1, 2011 at 9:00 a.m.

3 2. Plaintiff opening brief is currently due on February 4, 2011.

4 3. On January 14, 2011, plaintiff's counsel learned that he will require surgery for a
5 major medical problem. The surgery is set to occur on January 18, 2011. It is uncertain exactly
6 how long counsel will be hospitalized or what the recuperation period will be. Plaintiff's counsel
7 was unaware of this medical condition prior to the week of January 10, 2011.

8 4. In light of the foregoing, the Parties wish to continue the briefing schedule
9 previously set by the Court for approximately sixty (60) days. The new briefing schedule being
10 proposed is as follows:

11	Plaintiff's Opening Brief due:	April 1, 2011
12	Defendant's Opposition and Cross-Motion due:	April 15, 2011
13	Plaintiff's Reply and Opposition due:	April 29, 2011
14	Defendant's Reply due:	May 6, 2011
15	Hearing date:	June 3, 2011 at 9:00 a.m.

16 The Parties also request that the Further Case Management Conference currently
17 scheduled for April 1, 2011 be continued to June 3, 2011, immediately following the oral
18 argument on the summary judgment motions.

19 In light of the foregoing, good cause exists for the continuance. The Parties request that
20 the Court modify the briefing schedule as set forth above, or to some time thereafter, convenient
21 to the Court and the Parties.


