17 Plaintiffs counsel Richard Sax has a Motion to Withdraw scheduled to be heard
 18 on December 2, 2010.

19 The Discovery cut off deadline is presently scheduled for December 7, 2010.

20 The trial date is currently set for June 13, 2011.

21 As a result of a Motion to Withdraw by plaintiffs counsel and subject to the
 22 permission and order of this court, it is hereby stipulated by and between the attorneys
 23 for the parties to this action that all discovery deadlines be postponed from December 7,
 24 2010 to approximately March 7, 2011 and it is further stipulated that the trial date
 25 currently set for June 13, 2011 be continued to a date set by the Court after August,
 26 2011.

27 This stipulation does not change the fact that Defendants served Interrogatories
 28 and Request for Production of Documents on Plaintiff on August 18, 2010.

1 Subsequently, Defendants agreed to two extensions, but Plaintiff has failed to respond
2 to discovery. Despite this stipulation, Plaintiff's Responses are now untimely and
3 Plaintiff has waived all objections to Defendants' Interrogatories, Set No. One and
4 Defendants' Request for Production of Documents, Set No. One.
