9 WHEREAS, Dell filed a Second Amended Complaint (Dkt. Nos. 89 and 3241, August 8,
10 2011) in the above-captioned case against Defendants Sharp Corporation, Sharp Electronics
11 Corporation, Epson Imaging Devices Corporation, Epson Electronics America, Inc., HannStar
12 Display Corporation, Toshiba America Electronic Components, Inc., Toshiba America
13 Information Systems, Inc., and Toshiba Corporation, Toshiba Mobile Display Co., Ltd.
14 (“Stipulating Defendants”), as well as newly-added Defendants AU Optronics Corporation, AU
15 Optronics Corporation America, Inc., Chi Mei Innolux Corporation, Chi Mei Optoelectronics
16 Corporation, Chi Mei Optoelectronics USA, Inc., CMO Japan Co., Ltd., Nexgen Mediatech, Inc.,

18 WHEREAS, Stipulating Defendants have requested, and Dell has agreed to, additional
19 time for Stipulating Defendants to answer Dell’s Second Amended Complaint;

20 WHEREAS, this extension will not alter the date of any event or any deadline already
21 fixed by the Court;

22 NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED by and among the
23 undersigned counsel, on behalf of their respective clients, Dell, on the one hand, and Stipulating
24 Defendants on the other hand, that Stipulating Defendants’ deadline to answer Dell’s Second
25 Amended Complaint shall be September 1, 2011.
