## 1 STIPULATION TO AMENDED MEDIATION DATE 2 Pursuant to the agreement of the parties as set forth in the Joint Case Management 3 Conference statement dated July 16, 2010, mediation is to be completed by October 4, 2010. 4 On September 21, 2010, this court approved an extension of time to mediate to October 5 25, 2010. The extension was based on the determination of the parties that settlement prospects 6 are enhanced with such additional time. However, the parties have now identified a scheduling 7 conflict which was not previously apparent, and therefore find they must again extend the time 8 for mediation. 9 The parties therefore agree to extend the time for completion of mediation to November 10 17, 2010, with a mediation date set now for November 11, 2010.
