24 YOU ARE HEREBY COMMANDED TO GARNISH FOR THE BENEFIT OF  
25 THE UNITED STATES OF AMERICA THE WAGES, SALARY, OR COMMISSION IN  
26 YOUR CUSTODY, CONTROL, OR POSSESSION IN WHICH THE DEFENDANT-  
27 JUDGMENT DEBTOR HAS AN OWNERSHIP INTEREST.

28 The name, SSN XXX-XX-5642, and last known address of the person who is

1 the defendant-judgment debtor (hereinafter “debtor”) in this action and whose property  
2 is subject to this Writ are as follows:

6           This Writ has been issued at the request of the United States of America to  
7 enforce the collection of a civil judgment entered in favor of the United States against  
8 the debtor for a defaulted student loan in the amount of \$141,731.24. There is a  
9 balance of \$143,831.08 due on the judgment, which amount includes costs and  
10 interest computed through January 20, 2017.

11           The following are the steps that you must take to comply with this Writ. If you  
12 have any questions, you should consult with your attorney.

13           1. Pursuant to 28 U.S.C. § 3205(c)(2)(F), if you have in your custody, control,  
14 or possession any property of the debtor, including wages, salary, or commissions, in  
15 which the debtor has a substantial nonexempt interest, or if you obtain custody,  
16 control, or possession of such property while this Writ is in effect, you must  
17 immediately withhold such property from the debtor and retain it in your possession  
18 until you receive instructions from the Court which will tell you what to do with the  
19 property. The United States has requested that the sum of 25% of the debtor’s  
20 disposable earnings, which under California law represents the nonexempt portion of  
21 the debtor’s earnings, be withheld from the defendant’s earnings.

22           2. Pursuant to 28 U.S.C. § 3205(c)(2)(E), you are required to answer this Writ  
23 within 10 days after service of this Writ upon you. You must answer the Writ even if  
24 you do not have in your custody, control, or possession any property of the debtor.  
25 Pursuant to 28 U.S.C. § 3205(c)(4), your answer must state, under oath, the following  
26 information:

27           a.       Whether or not you have in your custody, control, or possession, any  
28                   property owned by the debtor in which the debtor has a substantial

- 1 nonexempt interest, including nonexempt, disposable earnings;
- 2 b. a description of such property and the value of such property;
- 3 c. a description of any previous garnishments to which such property is
- 4 subject and the extent to which any remaining property is not exempt;
- 5 and
- 6 d. the amount of the funds you anticipate owing to the debtor in the future
- 7 and whether the period for payment will be weekly or another specified
- 8 period.

9 For your convenience, a form which addresses the above-requested information is  
10 attached and may be used to Answer the Writ.

11 3. After you complete the answer under oath, pursuant to 28 U.S.C. §  
12 3205(c)(2)(E) & (c)(4), within ten (10) days after service of this Writ upon you, you  
13 must mail or deliver the original Answer bearing the original signature of the person  
14 preparing the answer to the Court at the following address:

1 IF YOU FAIL TO ANSWER THIS WRIT OR FAIL TO WITHHOLD PROPERTY  
2 IN ACCORDANCE WITH THIS WRIT, THE UNITED STATES MAY PETITION THE  
3 COURT FOR AN ORDER REQUIRING YOU TO APPEAR BEFORE THE COURT TO  
4 ANSWER THE WRIT AND TO WITHHOLD PROPERTY IN ACCORDANCE WITH  
5 THE WRIT BEFORE THE APPEARANCE DATE. IF YOU FAIL TO APPEAR OR DO  
6 APPEAR AND FAIL TO SHOW GOOD CAUSE WHY YOU FAILED TO COMPLY  
7 WITH THIS WRIT, THE COURT WILL ENTER A JUDGMENT AGAINST YOU FOR  
8 THE VALUE OF THE DEBTOR'S NONEXEMPT INTEREST IN SUCH PROPERTY  
9 (INCLUDING NONEXEMPT DISPOSABLE EARNINGS). THE COURT MAY ALSO  
10 AWARD A REASONABLE ATTORNEY'S FEE TO THE UNITED STATES AND  
11 AGAINST YOU IF THE WRIT IS NOT ANSWERED WITHIN THE TIME SPECIFIED  
12 HEREIN AND IF THE UNITED STATES FILES A PETITION REQUIRING YOU TO  
13 APPEAR.

1 DO NOT WITHHOLD THE EXEMPT PORTION OF THE EMPLOYEE'S EARNINGS

2  
3 1. Earnings include any money (whether called wages, salary, commissions,  
4 bonuses, or anything else) paid for personal services, pension, or retirement.  
5 Vacation or sick pay is earnings subject to withholding as it is *received* by the  
6 employee.

7 2. Disposable earnings are different from gross pay or take-home pay. They  
8 are the earnings left after deducting the part which state or federal law requires an  
9 employer to withhold as mandatory deductions. Generally, these mandatory  
10 deductions are federal income tax, social security (FICA) tax, state income tax, state  
11 disability insurance, and payments to public employee retirement systems.  
12 Disposable earnings can change from pay period to pay period, whenever gross pay  
13 or required deductions change.

14 To determine earnings that<sup>1</sup> are eligible for withholding, and therefore must be  
15 withheld, see the chart below.

16 USE THE CHART BELOW TO DETERMINE NONEXEMPT DISPOSABLE
