1 Pursuant to Civil Local Rule 16-10(d), the parties respectfully submit this
2 Joint Case Management Conference Statement.

3 In their March 16, 2011 Joint Case Management Conference Statement, the
4 parties reported that they have engaged in a series of mediation sessions before
5 Retired Magistrate Judge Edward Infante and Catherine Yanni of the Judicial
6 Arbitration and Mediation Service (“JAMS”) and that, subject to Apple meeting
7 certain conditions, the parties would engage in another mediation session on April
8 13, 2012. The mediation session did not go forward on April 13, however, because
9 Apple did not meet those conditions prior to the scheduled mediation and, in any
10 event, Judge Infante became unavailable on April 13. The parties have tentatively
11 scheduled another session for April 27, 2011.

12 Plaintiffs will attend the next mediation session on April 27, 2012, if the
13 outstanding conditions have been met. Plaintiffs believe there are issues that could
14 benefit from the Court’s assistance at the scheduled April 26, 2012 Case
15 Management Conference and are prepared to discuss the status of the litigation in
16 detail, including the status of the parties’ mediation efforts in chambers if Apple is
17 willing to waive applicable mediation privileges.

18 Apple does not intend to waive the mediation privilege, however, and does
19 not believe there are issues to be addressed by the Court at this time, but of course
20 will be prepared to address any issues that the Court may wish to discuss.
