**STIPULATION AND (PROPOSED)
 ORDER SETTING HEARING AND
 BRIEFING SCEHDULE FOR MOTION
 FOR CLASS CERTIFICATION**

RECITALS

1
2 1. This is a stipulation and proposed order to establish a class certification briefing
3 schedule following a series of discovery disputes, the completion of certain discovery, and
4 related agreements to continue the deadline for filing the motion for class certification.

5 2. The parties have been engaging in class-certification related discovery and
6 meeting and conferring in order to resolve discovery disputes. During this time they have
7 entered into a series of stipulations extending class certification deadlines.

8 3. On or about June 30, 2011, the parties agreed to extend the deadline again and
9 that they would wait until pre-certification discovery plan could be developed before seeking an
10 additional stipulated order thereon.

11 4. Discovery has now progressed to the point where the parties seek to set such a
12 class certification briefing schedule.

STIPULATION

15 THEREFORE, the parties stipulate and request that the Court order as follows:

16 1. Plaintiffs' deadline to file their motion for class certification is extended from
17 September 12, 2011 to January 9, 2012.

18 2. Wells Fargo's opposition to the motion for class certification shall be due
19 February 8, 2012.

20 3. Plaintiffs' reply brief in support of class certification shall be due February 22,
21 2012.

22 4. This stipulation is without prejudice to the rights, claims, defenses and arguments
23 of all parties.
