1 WHEREAS, Defendant Sony Computer Entertainment America, LLC (“SCEA”)
2 filed its bill of costs after close of business on December 22, 2011, and

3 WHEREAS, Plaintiffs intend to object SCEA’s claimed costs, and

4 WHEREAS, Plaintiffs have filed a Notice of Appeal of the underlying dismissal of
5 this action,

6 NOW THEREFORE THE PARTIES STIPULATE that all proceedings relating to
7 SCEA’s bill of costs, including the deadline for Plaintiffs to file their objections, and the
8 Clerk’s taxing of costs, should be and are stayed pending the resolution of the appeal of
9 this matter.

10 THE PARTIES FURTHER STIPULATE that in the event that SCEA is entitled to
11 claim costs following the Ninth Circuit’s decision, the parties will meet and confer at that
12 time regarding an appropriate new deadline for Plaintiffs to file their objections to
13 SCEA’s cost bill and for the Clerk to tax costs. No interest on any claimed costs shall
14 accrue pending the appellate proceedings.
