¹ Community Resources Fundraising is the last remaining defendant in the litigation. Neither Best Fundraising Company, Inc., nor Profit Specialties were ever served with the Complaint and summons in this matter. Plaintiff has been unable to locate Best Fundraising Company, Inc. or responsible parties therefore, and learned that two individuals doing business as Profit Specialties received a discharge from the United States Bankruptcy Court for the Eastern District of California in 2009. Dismissal of the claims against defendant Community Resources Fundraising therefore will enable a dismissal of the action in its entirety.
