**STIPULATION AND ~~PROPOSED~~
 ORDER EXTENDING TIME TO FILE
 MOTION TO STRIKE ANSWER**

1 WHEREAS, pursuant to Federal Rule of Civil Procedure 12(f), plaintiff's deadline for
2 filing a motion to strike defendant Morgan Slade's Answer to Complaint ("Answer") is Friday,
3 June 25, 2010;

4 WHEREAS, the parties have twice met and conferred in good faith regarding plaintiff's
5 anticipated motion to strike the affirmative defenses in the Answer, but have been unable to
6 resolve the matter without Court intervention;

7 WHEREAS, the parties are engaged in settlement discussions that would make plaintiff's
8 anticipated motion to strike moot;

9 WHEREAS, the parties agree it would be beneficial and more efficient to focus their
10 efforts on these settlement discussions;

11 WHEREAS, this is the first request made for an extension of time in this case, and would
12 not affect the case schedule; and

13 WHEREAS, the parties have agreed to a schedule that extends by one week plaintiff's
14 time to file a motion to strike the Answer.

15 IT IS HEREBY STIPULATED AND AGREED between the undersigned parties that
16 plaintiff's deadline for filing a motion to strike the Answer shall be extended to Friday, July 2,
17 2010.
