1 This Court, having considered Defendant Yelp! Inc.'s ("Yelp") Ex Parte
2 Application to Consolidate Related Cases For All Purposes And To Set Dates For
3 Consolidated Amended Complaint, Responsive Pleading, And Joint Scheduling
4 Conference ("Yelp's Ex Parte Application"), and being of the opinion that good
5 cause has been shown,

6 IT IS HEREBY ORDERED that Yelp's Ex Parte Application is GRANTED
7 as follows:

- 8 1. Pending the resolution of Yelp's Ex Parte Application, Yelp is relieved
9 of any obligation it would otherwise have to respond to the complaints
10 currently on file in Case Nos. CV 10-01340 VBF (SSx) and CV 10-
11 01578 VBF (SSx).
- 12 2. Case Nos. CV 10-01340 VBF (SSx) and CV 10-01578 VBF (SSx) are
13 consolidated for all purposes.
- 14 3. Plaintiffs shall file a consolidated and superseding amended complaint
15 30 days after the entry of this Order.
- 16 4. Yelp is relieved of its obligation to file separate responsive pleadings
17 to the complaints currently on file in each case and instead Yelp shall
18 file a single responsive pleading to the consolidated amended
19 complaint 30 days after it is filed.
- 20 5. The Scheduling Conference currently set for April 26, 2010 at 8:30
21 a.m. shall be taken off calendar and the Parties are relieved of their
22 obligations in connection with the April 26 Scheduling Conference,
23 including preparation of the Joint Rule 26(f) Report currently due
24 April 12.
- 25 6. The joint Scheduling Conference shall be scheduled for a new date, at
26 least 30 days after Yelp files its responsive pleading(s).
