5 IT IS HEREBY ORDERED that Yelp's Motion is GRANTED as follows:

6 1. The following related cases shall be and hereby are consolidated for all

8 01340-VBF(SSx) (C.D. Cal. filed Feb. 23, 2010); and *Christine LaPausky d/b/a*

11 2. Plaintiffs shall file a consolidated and superseding amended complaint  
12 within 14 days after the date of this Order.

13 3. Yelp shall be relieved of the obligation of filing an answer, motion to  
14 dismiss, or other response to the complaint in each separate case; instead, Yelp shall  
15 file a single answer, motion to dismiss, or other response to the consolidated  
16 amended complaint within 21 days after it is filed.
