1	Beck & Lee Business Trial Lawyers ("Beck & Lee") hereby withdraws its motion for	
2	appointment of Beck & Lee as co-lead interim class counsel with The Weston Firm ("Weston")	
3	[D.E. 65-1, 86]. Shortly after Weston and Beck & Lee filed their supplemental memorandum in	
4	support of their lead counsel application on July 26, 2010 [D.E. 86], Beck & Lee's attorneys,	
5	Elizabeth Lee Beck and Jared Beck, received information that Weston improperly recruited a	
6	class action plaintiff through offer of a "kickback" and employment of a runner/capper. Before	
7	Beck & Lee could complete its investigation of the truth and scope of Weston's practices, on	
8	August 12, 2010, Weston abruptly and without prior notice or explanation announced it was	
9	terminating the firms' written joint prosecution agreement and, the same day, sued Beck & Lee	
10	and another co-counsel law firm, Reese Richman LLP, in the Southern District of California.	
11	The facts of these events are set forth in the following papers which Beck & Lee filed earlier
