3 4. PRETRIAL MOTIONS. All pretrial motions must be filed and served pursuant to
4 Civil Local Rule 7. All pretrial motions shall be heard no later than February 23, 2012.

5 5. PRETRIAL STATEMENTS. At a time convenient to both, counsel shall meet and
6 confer to discuss preparation of a joint pretrial statement, and on or before March 15, 2012, counsel
7 shall file a Joint Pretrial Statement in accordance with the attached Standing Order for Final Pretrial
8 Conference.

9 6. PRETRIAL CONFERENCE. The final pretrial conference will be held on **March**
10 **29, 2012 at 10:00 am.**, in Courtroom 3, 17th Floor, United States Courthouse, 450 Golden Gate
11 Avenue, San Francisco, California. Each party or lead counsel who will try the case shall attend
12 personally.

13 7. TRIAL DATE. Jury trial shall commence on **April 9, 2012 at 9:00 a.m.**, in
14 Courtroom 3, 17th Floor, United States Courthouse, 450 Golden Gate Avenue, San Francisco,
15 California.
