23	to state court. Because not all parties consented to magistrate judge jurisdiction, this matter was
24	reassigned to the undersigned.
25	Prior to reassignment, Judge Laporte issued a report and recommendation on October 19,
26	2010 granting plaintiff's motion to remand, on the grounds that this Court lacks subject matter
27	jurisdiction. Lopez did not oppose the report and recommendation. While there is some concern
28	that Lopez-due to her failure to provide an accurate address or to attend the CMC-did not have

an opportunity to oppose plaintiff's oral motion. This concern is allayed, however, by Judge
Laporte's report and recommendation. Subject matter jurisdiction is so clearly lacking that

will not be awarded. The clerk is directed to transfer the matter to the Alameda Superior Court.
