15 On August 3, 2010, the Court entered an order of dismissal and judgment in favor of the
16 United States due to pro se plaintiff Chrystal Ann Poole's failure to pay the requisite filing fee of
17 \$350.00. Poole filed a request to vacate the judgment on August 19, 2010. The Court considers
18 Poole's request to be a motion for relief from judgment pursuant to Federal Rule of Civil Procedure
19 60(b), which must be made "within a reasonable time" and may be granted if the moving party
20 shows "mistake, inadvertence, surprise, or excusable neglect." Fed. R. Civ. P. 60(b); *see also*,
21 *Backlund v. Barnhart*, 778 F.2d 1386, 1388 (9th Cir. 1985). As Poole maintains in her motion, the
22 Court's docket reflects that Poole paid the \$350.00 filing fee on August 3, 2010, the same day that
23 the Court entered its judgment in favor of the United States. In light of the liberal construction of
24 procedural requirements afforded to pro se litigants, *see Abassi v. INS*, 305 F.3d 1028, 1032 (9th
25 Cir. 2002), and given the lack of any response from the United States on Poole's request, the Court
26 hereby grants plaintiff relief from its previously entered order of dismissal and vacates the judgment
27 entered on August 3, 2010. The clerk is directed to reopen the above entitled action.
