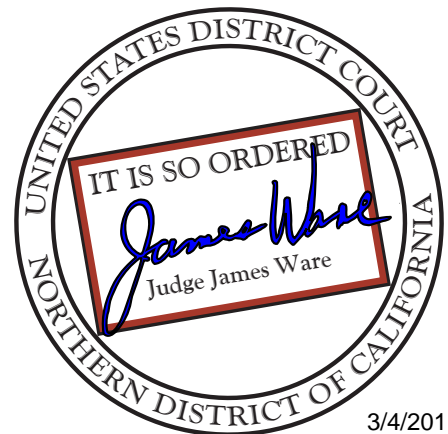

1 Pursuant to ADR L.R. 6-5 and Civil L.R. 7-11, the parties, Plaintiff Lisa Marie Perri and
2 Defendant CA, Inc., through their respective counsel, hereby stipulate as follows:

3 WHEREAS, this Court originally ordered that an ADR session be completed in this
4 matter by February 1, 2011 (Doc # 17);

5 WHEREAS, due to commitments of the parties, their counsel, and Jamie Dupree, the
6 Mediator assigned to this case, the parties requested, and the Court granted an extension to
7 conduct the mediation session by March 1, 2011 (Doc # 23);

8 WHEREAS, due to commitments of the Defendants, and scheduling conflicts of their
9 counsel caused by preparation for trial in another matter, a new mediation date has been set for
10 May 17, 2011;

11 WHEREAS, all parties, their representatives, counsel, and Ms. Dupree are available on
12 such date and no prior date would accommodate all schedules; and

13 THEREFORE, the parties collectively request that the Court issue an Order extending the
14 date by which to hold an ADR process to and including May 31, 2011.




