 28 approximately 60 days as follows:

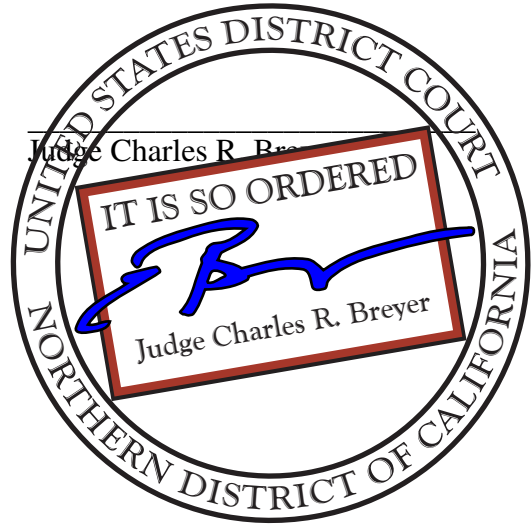
- a. Plaintiff’s Supplemental Brief is due: July 5, 2011
