1 Amended Complaint. Defendant Alameda County Medical Center was successful with their  
2 motion to dismiss the Amended Complaint.

3 Counsel have met and conferred concerning ADR and to address scheduling ADR.

4 Now that the status of the parties has become settled, completion of ADR is expected to  
5 be by August 31, 2011.

6 Pursuant to this change, the Parties also request that the next Case Management  
7 Conference, currently scheduled for June 3, 2011, be continued to September 2, 2011.

8 The Parties have been cooperating while completing discovery. Accordingly,  
9 scheduling the Case Management Conference after ADR/mediation will likely be a more  
10 productive use of the Court's time.


