1 On November 16, 2011, Defendants filed a Notice of Motion and Motion to Dismiss First
2 Amended Complaint Pursuant to Fed. R. Civ. P. 12(b)(6) to be heard on December 22, 2011, at
3 1:30 p.m., or as soon thereafter as the matter may be heard by this Court.

4 Due to scheduling issues, Plaintiffs' counsel requested that Defendants agree to extend
