 25 The parties in this matter stipulated that plaintiff could extend the time for filing her motion
 26 for summary judgment from April 29, 2011 to May 2, 2011 because plaintiff recently received the
 27 transcript of the deposition of Dr. Stephen Dell and the brief is taking somewhat longer to prepare
 28 than anticipated. Defendants received plaintiff's motion late in the day on May 2, 2011.

1 Defendant's opening brief and opposition to plaintiff's motion for summary judgment is set to
2 be filed on May 13, 2011. However, like plaintiff, the briefs are taking longer than expected.

3 Accordingly, the parties through their counsel of record hereby stipulate that Defendant Royal
4 & Sunalliance Group Insurance Plan and Real Party in Interest Life Insurance Company of North
5 America have until Monday May 16, 2011 to file their opposition to plaintiff motion for summary
6 judgment and their cross motion for summary judgment. All reply briefs will be file on or before
7 May 23, 2011.

8 All other deadlines and the July 1, 2011 hearing date will remain unchanged.


