CURRY, Warden, 13 Respondent. 14 15 INTRODUCTION 16 Petitioner, a prisoner of the State of California, currently incarcerated at the 17 California Men's Colony in San Luis Obispo, California, has filed a habeas corpus 18 petition pursuant to 28 U.S.C. § 2254 challenging the decision of the Board of Parole 19 Hearings ("Board") to deny him parole in 2008. He has paid the filing fee. This order 20 directs Respondent to show cause why the petition should not be granted. 21 **BACKGROUND** 22 According to the petition, in 1985, Petitioner was convicted of second-degree 23 murder and was sentenced to a term of 17 years-to-life in state prison. In this habeas 24 action, Petitioner does not challenge his conviction, but instead challenges the decision 25 of the Board to deny him parole. He alleges that he has exhausted state judicial remedies 26 as to all of the claims raised in his federal petition. 27 // 28

DISCUSSION

I Standard of Review

This court may entertain a petition for a writ of habeas corpus "in behalf of a person in custody pursuant to the judgment of a State court only on the ground that he is in custody in violation of the Constitution or laws or treaties of the United States." 28 U.S.C. § 2254(a).

It shall "award the writ or issue an order directing the respondent to show cause why the writ should not be granted, unless it appears from the application that the applicant or person detained is not entitled thereto." *Id.* § 2243.

II <u>Legal Claims</u>

Petitioner claims that the denial of parole violated his right to due process because it was not supported by sufficient evidence of his current dangerousness. Liberally construed, the allegations are sufficient to warrant a response from Respondent.

CONCLUSION

For the foregoing reasons and for good cause shown,

- 1. The Clerk shall serve by certified mail a copy of this order and the petition, and all attachments thereto, on Respondent and Respondent's attorney, the Attorney General of the State of California. The Clerk also shall serve a copy of this order on Petitioner.
- 2. Respondent shall file with the Court and serve on Petitioner, within **ninety** (60) days of the date the order is filed, an answer conforming in all respects to Rule 5 of the Rules Governing Section 2254 Cases, showing cause why a writ of habeas corpus should not be granted. Respondent shall file with the answer and serve on Petitioner a copy of all portions of the state record that have been transcribed previously and that are relevant to a determination of the issues presented by the petition. If Petitioner wishes to respond to the answer, he shall do so by filing a traverse with the Court and serving it on Respondent within **thirty** (30) days of the date the answer is filed.
 - 3. Respondent may file a motion to dismiss on procedural grounds in lieu of an

answer, as set forth in the Advisory Committee Notes to Rule 4 of the Rules Governing Section 2254 Cases. If Respondent files such a motion, Petitioner shall file with the Court and serve on Respondent an opposition or statement of non-opposition within **thirty** (30) days of the date the motion is filed, and Respondent shall file with the Court and serve on Petitioner a reply within **fifteen** (15) days of the date any opposition is filed.

4. It is Petitioner's responsibility to prosecute this case. Petitioner must keep the Court informed of any change of address by filing a separate paper captioned "Notice of Change of Address." He must comply with the Court's orders in a timely fashion. Failure to do so may result in the dismissal of this action for failure to prosecute pursuant to Federal Rule of Civil Procedure 41(b).

IT IS SO ORDERED.
