1 WHEREAS plaintiff TracFone Wireless, Inc. (“TracFone”) filed the above captioned
2 lawsuit on May 4, 2010 in United States District Court, Southern District of Florida;
3

4 WHEREAS TracFone filed a Notice of Tag-Along Action to In re TFT-LCD (Flat Panel)
5 Antitrust Litigation, Case No. M:07-CV-1827-SI, MDL No. 1827, on May 20, 2010;

6 WHEREAS on June 22, 2010, the case was transferred to the Northern District of
7 California, and assigned to the Honorable Susan Illston;

8 WHEREAS on July 28, 2010, the Court entered a stipulated order waiving service of the
9 Complaint for certain Defendants and extending the time within which the Defendants must move
10 against, answer or otherwise respond to TracFone’s Complaint to September 17, 2010, or until 45
11 days from the date that TracFone amended its Complaint, whichever was later (see Dkt. No.
12 1929);
13

14 WHEREAS on November 9, 2010, the Court entered a stipulation permitting email
15 service of the Complaint for Chunghwa Picture Tubes, Ltd. (“Chunghwa”) and extending the time
16 within which the Chunghwa must move against, answer or otherwise respond to TracFone’s
17 Complaint to 45 days from the date that TracFone amended its Complaint (see Dkt. No. 2126);
18

19 WHEREAS TracFone served Defendants with an Amended Complaint on November 10,
20 2010, making Defendants’ deadline for moving against, answering, or otherwise responding to
21 TracFone’s Amended Complaint December 27, 2010;

22 WHEREAS, the parties have agreed, pursuant to Civil L.R. 6-1(a), to extend the time
23 within which the Defendants must move against, answer or otherwise respond to TracFone’s
24 Complaint an additional two weeks;

26 NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED by and among the
27 undersigned counsel, on behalf of their respective clients, TracFone, on the one hand, and
28 defendants AU Optronics Corporation, AU Optronics Corporation America, Inc., Chi Mei
