1 In light of the recent denial of *en banc* review in *Starr v. Baca*, No. 09-55233, on October
2 5, 2011, and in light of the fact that the facility where the plaintiff is housed has been on lock-
3 down status, which has impeded communication between the plaintiff and counsel, and to permit
4 plaintiff to obtain limited discovery for the purpose of filing an amended complaint in conformity
5 with the Order of the Court entered August 5, 2011, the time within which Plaintiff will have to
6 file a second amended complaint be extended 45 days, from October 10, 2011, until November
7 25, 2011.

8 WHEREAS, in light of this stipulation and the fact that counsel for plaintiff is likely to be
9 engaged in trial on November 4, 2011, in a criminal case in Los Angeles County Superior Court,
10 the parties also stipulate to the continuance of the Case Management Conference, scheduled for
11 November 4, 2011, until after the amended complaint has been screened.
