) STIPULATION TO CONTINUE
) MEDIATION DEADLINE;

1 Plaintiffs and Defendant/Third-Party Plaintiff, by and through their counsel, hereby
2 stipulate and respectfully request that the Court so order that the deadline for mediation in the
3 above-entitled action be extended to July 29, 2011. The current deadline to complete mediation is
4 May 9, 2011. As set forth in the Stipulation to Continue the Mediation Deadline filed on March 4,
5 2011, Plaintiffs and Defendants are prepared to proceed with mediation with just Plaintiffs and
6 Defendants participation, although the Parties believe that in the interest of judicial economy, it
7 would be helpful for Third-Party Defendant Sedlacek, Inc. ("Sedlacek") to participate in the
8 mediation session. However, Sedlacek has failed to appear in the matter and entry of default was
9 entered against them on April 2, 2011. Plaintiffs and Defendants have been unable to schedule the
10 mediation before the current mediation deadline of May 9, 2011, but have exchanged
11 documentation that may be helpful in reaching a resolution of the litigation. The additional time, if
12 granted, will allow Plaintiffs and Defendants the opportunity to participate in the mediation
13 session. Accordingly, Plaintiffs and Defendant/Third-Party Plaintiff respectfully request that the
14 Court extend the deadline to complete mediation to July 29, 2011.
