

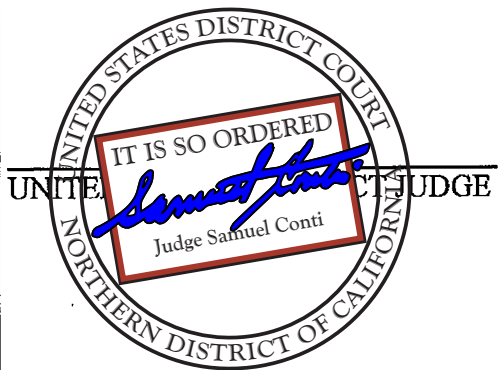


- 23 1. I contacted Katherine McDonough on May 3, 2011 and informed her that I need


