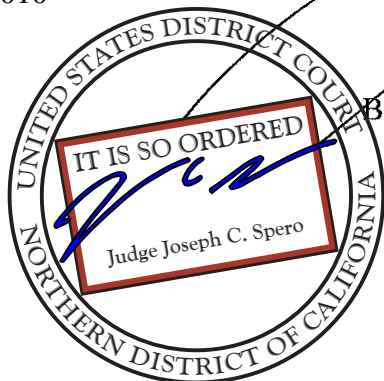
16 Plaintiffs hereby notify Defendants and the Court of their intent to move for default
