DECLARATION OF TOMAS MARGAIN

19 1. I am the attorney for Plaintiff in this action, and I have personal knowledge of each fact
 20 stated in this declaration.

21 2. The above matter is currently set for an Initial Case Management Conference set for
 22 January 24, 2011 with a Case Management Conference Statement due January 17, 2011.

23 3. I write to request a 30 day extension so that this matter may be fully settled and the
 24 Settlement reduced to a writing.

1 4. The parties have reached a settlement as to the amount. They are working out issues
2 regarding a payment plan. The corporate defendant is a restaurant that needs a structured
3 settlement.

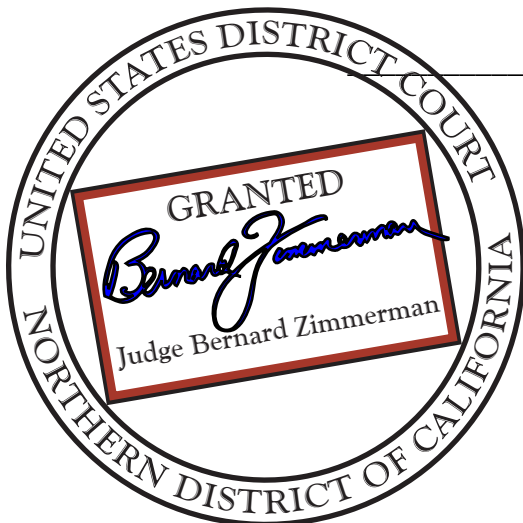
4 5. The 30 day period will allow us to finish this negotiation point and draft and execute a
5 written agreement. I anticipate dismissing the action and having language in the agreement
6 which would call for a penalty if I have to file in State Court to enforce the agreement. I want to
7 do this so that the Court does not need to retain jurisdiction during the period it would take to
8 complete the payments.

9 6. Defendants have retained James Macy a licensed attorney who practices in Sacramento.
10 We are trying to work out the last details but will not be able to do so by January 17, 2011.

11 7. The Summons Complaint and all papers have been served. Plaintiffs have consented to
12 the Jurisdiction of a Magistrate. Defendants have not yet made an appearance nor filed their
13 consent.
